I am directed to say that one post of Executive Engineer (Elect), is lying vacant and required to be filled on deputation basis in Delhi Agricultural Marketing Board.

The eligibility conditions for deputation of above mentioned post are as under:-

Executive Engineer (Electrical) - (a) Officer holding analogous posts on regular basis **or (b)** with 5 years regular service in the grade in the pay scale of PB-3 Rs.15600-39100 + GP 5400 **or (c)** 8 years regular service in the grade in the pay scale of PB-2, Rs. 9300-34800 + GP 4600 and possessing degree in Electrical Engineering.

Since, the Delhi Agricultural Marketing Board is a body corporate and a local authority as per section 6 of the Delhi Agricultural Produce Marketing (Regulation) Act, 1998 and follows the Rules/Regulations/instructions of the Govt., the laid down terms and conditions of deputation of the Govt. shall be applicable to the officer on deputation basis.
